Subjects of cross-industry publications in PIEB journal:

A. Applied Innovations and Technologies – Topics can be from physics, chemistry, biology, electronics, science and education, and other non-economic domains should discover PARTICULAR INFLUENCE OF INNOVATIONS ON SOCIAL AND ECONOMIC DEVELOPMENT, PROVIDE LINKAGE OF SOME CONCEPT WITH RESPECTIVE PRACTICAL DOMAIN /BUSINESS, ECONOMICS, SOCIUM/ OF DEVELOPMENT.

For general inspiration please refer to the following fields. Environment preserving innovations. Stimulation of innovations in the market; Modernization of power, introduction and improving resource saving technologies; Innovations in mechanical engineering and instrument making. Development hi-tech industries; Innovations in manufacture of materials, subjects of industrial and final consumption. Technologies in a manufacturing industry; Innovations in agriculture and agribusiness. Chemical technologies and biotechnologies for productivity and ecology; Innovative technologies in construction, civil and industrial transport systems; Nanotechnologies, microelectronics, information technologies, telecommunications; Innovations for health protection and improvements of the person, an environment; Innovations in education and a science.

B. Business and Economics – Any economics or business related field article may be accepted.

For example it may be from the following fields: The macroeconomic policy (the monetary and tax-budgetary policies, their influence on business environment); Reforms in real sector (manufacturing, agriculture, non financial services); Development and management of regional economies; Social policy and labor market; Economics, finance and management in enterprises; Direct foreign investments and foreign trade, international economics and regional integration; Development of a financial system (banks, insurance and investment companies, infrastructure of financial market); Financial and economic crises.

Structure and format of papers:

The volume of paper should not exceed 10 pages of A4 format. Articles must be written either in English or in Russian. Papers should be written in MS Word and formatted using Time New Roman font (size 12) with spacing 1.5. Tables and pictures must be handled with MS Word drawing tools or plain image and supported by source references. Literature references should be placed at the end of the paper and formatted respecting international writing norms (see www.pradec.eu).

Papers should be provided with the following requisites:

- Name of paper (English name is also required when a paper is in Russian); UDC code and also JEL when applicable (for economic topics); List of keywords (English version is also required when a paper is in Russian)
- Summary at the beginning (a maximum of 80 words - in few lines). English version is also required when a paper is in Russian.
- References in required format
- Author should precisely specify the following at the end of the paper: first name and surname; scientific degree; country of citizenship; author affiliation (a research or other organization (company)); e-mails (main and alternative); phones with international codes (office and mobile); the convenient detailed post address, on which author wishes to receive the journal when printed.

Submitted works should have research character and must be based on principles of scientific and a professional etiquette. The final decision on inclusion of paper in the PIEB will be made by Editorial Board. Editorial Board reserves its right to make technical and scientific editing. In case of not accepting the Board does not provide reviews and comments but only final decision about the publication.

Publication fee:

Standard publication fee is 150 Euro, due to pay only after the acceptance formal letter from the editor. The publisher can add VAT to these rates when it is feasible according to tax law and tax liability of invoice issuer. The paper will be published online with ISSN 1804-0527 (Online). **Important:** the main publication format for this journal is electronic (online, with the relevant ISSN - 1804-0527). Hard copy print can differ in date of issue from the online publication date. The fee is also subject to guarantee the sending of one printed copy (per paper not per author) via standard air mail to the first author of a published article. All accepted PIEB papers are made freely accessible on-line with free open access to any reader, individual and institutional.
